# MAY 22, 2018 MEETING HIGHLIGHTS

#### **Executive Session**



- Approved the April 24, 2018 Executive Session Minutes.
- Discussed homeowner and legal matters and Delinquency Report.

### **General Session**



- Approved the April 24, 2018 General Session Minutes.
- Accepted the April 30, 2018 Financial Statement.
- Horizon Lighting completed the installation of the correct style cross arms for the street light poles.
- The Board postponed final payment to Horizon Lighting until the final walk-thru inspection of the street light poles to ensure that they are plumb and straight.
- Jim Bradley indicated that he is working on the logistics for the street repairs project and for LaBelle-Marvin to draft letters to the utility companies (gas, water and electricity) to find out if they are planning to do any street work, as he does not want the street to be dug up after the street repairs project is complete.
- The landscape report indicated that Grant's Landscape Services has found a problem with spiders and mites in the Philodendron, which may need to be removed as they are getting old; the treatment of the Texas Privets is working; and they are working on the irrigation water audit. There will be some bare areas, as the landscape crew is working on the renovation of the Antigua slope.
- Approved the proposal for \$4,113.00 for miscellaneous landscape items discussed during the May landscape walk from Grant's Landscape Services.
- The Board is working on the renovation of the entrance monument sign letters and landscape lighting.
- Approved the proposal for \$565.00 to repair and paint the stucco planter wall at the corner of Antigua and Saint Roberts.
- Approved the following investments: (1) Roll over the Reserve CD for \$100,000.00 from Comerica for a term of six months with an interest rate of 1.55%, upon maturity on June 8, 2018; (2) Roll over the Reserve CD for \$50,579.36 from CIT Bank for a term of six months with an interest rate of 0.55%, upon maturity on June 13, 2018; and (3) Roll over the Reserve CD for \$51,276.03 from First Foundation Bank for a term of 16 months at the promotional interest rate of 2.00% as of March 2018, upon maturity on July 12, 2018
- Approved placing a lien for the delinquent account for APN #672-432-01 for outstanding assessments and applicable charges.

## PROPOSED REVISIONS TO ARCHITECTURAL COMMITTEE RULES

The proposed revisions to the Architectural Committee Rules were recently mailed to the membership, and the proposed text of the Rules Revisions are posted on the Association's website.

**<u>Purpose for the Rules Revision</u>**: The purpose for the revisions to the Rules includes, among other others: (a) further define the types of architectural improvements that require the prior written approval of the Architectural Committee ("Committee"), (b) further clarify the procedure by which members are to follow when submitting an architectural application ("Application") to the Committee, (c) address conflicts between the Rules and the Association's Declaration of Covenants, Conditions and Restrictions ("CC&R"), and (d) articulate the standards considered by the Committee when reviewing an Application.

<u>Adoption of the Rules</u>: The proposed revisions to the Rules may be adopted by the Board of Directors after thirty (30) days, pursuant to Civil Code section 4360. Please forward any comments on the proposed Rules in writing to the Association's Community Manager, Rosmen Paguio, CMCA, prior to the Board meeting scheduled for June 26, 2018: <u>rpaguio@keystonepacific.com</u>.
