## **BOARD MEETING HIGHLIGHTS—AUGUST 25. 2020**

### **Executive Session**

 Approved the July 28, 2020 Executive Session Board Meeting Minutes and discussed hearing, homeowner, delinquency and legal matters.



### **General Session**

- Approved the July 28, 2020 General Session Board Meeting Minutes, as submitted.
- Accepted and filed the August 19, 2020 Architectural Submittal Report.
- Reviewed and accepted the July 31, 2020 Financial Statement.
- Ratified the amount of \$15,870.00 for the August Reserve Transfer.
- Approved the Proposed Election Rules to be in compliance with SB 323 to be mailed to the membership for a 28-day comment period ,for adoption at a subsequent General Session Board meeting.
- Approved the proposal for \$1,405.000 for miscellaneous landscape items discussed during the May landscape walk.
- The Board invited Jim Bradley to attend the meeting to provide his input on the proposals for the street repairs project with his prior experience in dealing with the Saint John street repair project. He discussed the need for future planning so heavy construction equipment will not be driven on streets that have already been repaired.
- Approved hiring Ed Perez of LaBelle-Marvin, Inc. for soils and inspection and Ryan Zeber of Western Pacific Construction to be the project manager for the Saint Annes street repairs project, contingent upon Ed Perez getting an early start on the soil samples, street design and inspection, with a projected start date of early October. Mr. Perez will provide proposals to do asphalt repair patches for Saint Robert and Saint Michael.

Last summer, we redid the entire street on St. John. Now, those same repairs are coming to other streets.

Starting in October, we will redo St. Annes. St. Annes is in danger of collapsing. You can see the street falling apart in some sections. This needs to be done.

After that, we will repair the most broken parts of St. Michael. And then, we will repair Antigua and St. Robert.

This will all be temporarily disruptive. But it has to be done if we're going to have decent streets. We are responsible for our streets, not the City of Dana Point. We'll give you as much warning as possible.

Final note: In the last newsletter, a month ago, I referred to 160,000 COVID-19 deaths. Now it's up to 190,000 - an increase of 30,000 in one month. Keep wearing your masks. Observe social distancing. COVID-19 didn't "just go away" in the hot summer months. Use some common sense on this.
