BOARD MEETING HIGHLIGHTS—OCTOBER 27, 2020

Executive Session

 Approved the September 22, 2020 Executive Session Board Meeting Minutes and discussed homeowner, delinquency and legal matters.

General Session

- Approved the September 22, 2020 General Session Board Meeting Minutes, as submitted.
- Accepted and filed the October 21, 2020 Architectural Submittal Report.
- Reviewed and accepted the September 30, 2020 Financial Statement.
- Ratified the amount of \$15,870.00 for the October Reserve Transfer.
- Ratified the proposal for \$920.00 from Grant's Landscape services for miscellaneous landscape items discussed during the September landscape walk, except for the proposal for \$40.00 to install a Toyon tree, subject to confirmation of the maximum growth height for the tree at the next meeting.
- Approved the proposal for \$5,725.00 for the 2020 tree trimming, subject to verification that there is no duplicate tree trimmings.
- Approved the proposal for \$1,136.00 from Three Phase Electric to replace existing fixtures at the entrance with new warm LED lights.
- Approved the approve the second amended draft Reserve Study prepared by Advanced Reserve Solutions for the fiscal year 2021, with the reserve study reflecting that the Association will be 65.46% funded at fiscal year-end.
- Approved the 2021 draft Annual Budget and Reserve Maintenance Disclosure, with the dues to remain the same.
- Ed Perez of LaBelle Marvin, Inc. attended the meeting and discussed the proposal for the asphalt repairs for Antigua, Saint Robert and Saint Michael provided by Ryan Zeber of Western Pacific Construction. At this time, Jim Bradley discussed doing only minimal asphalt cement patchwork on top of needed sections of the street at Antigua, Saint Robert and Saint Michael just to get through the winter. He recommended to wait until there is Reserve funding saved up to do the tear-out/street rebuild of at either Saint Michael or Antigua. Ed Perez agreed with this plan.
