#### **BOARD MEETING HIGHLIGHTS—JANUARY 2021**

#### **Executive Session**

 Approved the November 24, 2020 Executive Session Board Meeting Minutes and discussed homeowner, delinquency and legal matters.

#### **General Session**

- Approved the November 24, 2020 General Session Board Meeting Minutes, as submitted.
- Accepted and filed the January 19, 2021 Architectural Submittal Report.
- Reviewed and accepted the November 30, 2020 and December 31, 2020 Financial Statements.
- Ratified the amount of \$15,870.00 for the January Reserve Transfer.
- Rolled over the following upon maturity on February 13, 2021:
  (1) Reserve CD for \$51,599.97 at the rate of 0.55% for a term of 6 months; and (2) Reserve CD for \$51,551.46 at the rate of 0.55% for a term of 6 months.
- Approved the proposal for \$875.00 to do the 2020 tax and audit from Inouye, Shively, Klatt & McCorvey.
- Approved the proposal for \$15,750.00 from Western Pacific Construction to do the concrete patchwork repairs for the streets at Antigua, Saint Robert and Saint Michael and the proposal for \$1,200.00 from LaBelle Marvin, Inc for the street repairs inspection fees. They anticipate a one-day closure with two days to complete the work in early spring.
- The street signs project has been moved up to a March installation date due to COVID-19 setbacks at the foundry.
- The tree trimming at 1 Antigua has been completed by Grant's Landscape Services.

About five years ago, "A Man Called Ove" by Fredrik Backman was on all the bestseller lists. My favorite reading this month: *The Burning of Washington* by Anthony Pitch, an obscure book about when the British invaded the Capital in Washington and burnt it, a book that is suddenly relevant again; and Shakespeare's *Julius Caesar*, about a man (Marc Antony) who gives an oration to a crowd ("Friends, Romans, Countrymen") that riles the crowd into a mob that hunts and kills Roman senators. Some works of literature never go out of style.
