periodically to make sure they are not affecting your neighbor or their property.

- Be a good neighbor to the Association vendors! Residents should not be giving direction, harassing, verbally abusing or threatening the Association vendors who are in the community under contract by the Board of Directors. If you have a complaint about a vendor or the job they are doing, submit your complaint in writing to Management, and it will be included in the Board packet for Director review.
- Trash cans should be placed at the curb no earlier than
  Wednesday night, and retrieved no later than Thursday night.
- Dog waste is to be retrieved immediately after deposited in the Antigua common areas and residential landscaped areas.
- If parking a vehicle on the street, the vehicle must be facing in the direction of the correct flow of traffic for the side of the street. Parking against the flow of traffic is prohibited.
- Residents will be allowed to park 2 cars in front of their homes during holiday seasons. For example, for Thanksgiving, it would be 11/21-11/27.

During the last few years, there have been major improvements in our community. Two years ago, we redid the entire St. John street. Earlier this year, we redid patches on Antigua and St. Michael, and the entire St. Annes street. By the time you read this, we will have redone the St. Michael culde-sac. Still to come is the rest of St. Michael and more repairs on St. Roberts and Antigua. These are all major projects.

Along with all this, our landscaping has greatly improved, under the guidance of Beth Gilovich. That's on top of the major overhaul of Monarch Beach Drive undertaken by the Monarch Beach Master Association. All in all, our neighborhood looks much better than it did two years ago.

Robust landscaping and wide clean streets, as well as wonderful beach weather, is what differentiates this part of Orange County from the northern part of the county. Where there are no HOAs, landscaping is hit-and-miss depending on the individual neighbors, and roads get repaired whenever the City gets around to it. I prefer our system.

We're also acting proactively to upgrade the retaining wall behind the even-numbered homes on St. Kitts. This requires the cooperation of all of the homeowners. We know there's a drought, but we still have to act on the presumption that there will be some rain this winter and that water will run off the hillside, and we have to prepare for it.
